- Truck drivers must ensure that their vehicles are on level ground before tipping.
- Before leaving the tipping area, the rear doors of vehicles must be closed and hoists lowered.
- No tip-over axle trailers are permitted on landfill sites.

Assistance to elderly or physically disabled customers who need help in unloading their vehicles can be provided. Before your visit, please phone 1300 651 116 for arrangements to be made.

Our Pricing Policy

- Please declare all wastes and recyclable materials upon arrival at the weighbridge.
- All vehicles are weighed in and out to calculate the net weight disposed. Weight is rounded to the nearest 20kg.
- Prices are set according to the waste type. Most wastes are charged by weight. However, certain items are charged by quantity. Please refer to the pricing table for further information.
- A minimum charge applies to all chargeable waste loads.
- When the minimum charge has been exceeded, a two-tiered tonnage rate applies for chargeable waste. Tonnage rates for the same waste type vary according to load weight.
- Higher charges apply to bulky, special and difficult to handle wastes.
- The Goods and Services Tax (GST) and the Section 88 Waste Levy are included in waste charges.
- Non-account customers paying by cash may be required to leave a cash deposit at the weighbridge before disposing of their wastes.
- Non-account customers paying by credit card or EFTPOS may be required to leave some form of recognised identification or deposit at the weighbridge until their transaction has been completed.
- WSN Environmental Solutions reserves the right to alter prices at any time.

Payment Arrangements

All centres accept cash, EFTPOS and credit cards (Visa, Mastercard and Bankcard only). The minimum EFTPOS and credit card transaction is \$15.00. Cheques are not accepted.

Customers with minimum transactions of \$500 per month may be eligible to open an account. Please call 1300 651 116 for further information.

ACCEPTANCE CRITERIA

You can minimise your waste disposal costs by separating those materials that can be disposed of free of charge from chargeable wastes. Pre-sorted loads of the following materials are accepted free at all centres. Please note acceptance conditions apply at some centres.

Free materials

Cans

Aluminium and steel cans accepted at all centres.

Gas cylinders

Only LPG, Halon (yellow fire extinguishers) cylinders and fire extinguishers up to 9kg each can be accepted. All centres are authorised Halon collection points. Please contact your distributor for information regarding disposal of other types of cylinders. We do not accept LPG car cylinders.

Two cylinders per day are accepted at no charge.

Glass bottles and jars

Separated green, brown and clear glass accepted.

Paper and cardboard

Clean newspapers, writing papers, cardboard boxes and packaging accepted.

Plastic bottles and containers

All rigid plastics and containers accepted.

Scrap metals

Ferrous (eg steel) and non-ferrous (eg aluminium, brass, copper, stainless steel) accepted. Size limitations at some sites. Whitegood items (eg fridges, stoves, washing machines) accepted. Limit of four whitegoods per visit at Artarmon.

Car bodies accepted at Chullora, Eastern Creek, Jacks Gully and Lucas Heights.

All fluids from car bodies and drums must be drained.

Centres cannot accept sealed containers (drums) and large reinforced steel items.

Sump oil

Up to 20 litres per visit at all centres.

Vehicle batteries

Accepted at all centres.

Chargeable materials

Dry material

Mixed quantities of general waste including household junk, furniture, mixed paper, plastic, glass, metal, timber, office partitioning and other dry material. Loads must not contain asbestos, food, plant matter or liquids. Loads containing garden organics will be charged as mixed waste.

Excluded wastes

Any material that does not meet our conditions of acceptance will be excluded. This includes radioactive, clinical and quarantine wastes and goods labelled as dangerous.

This information can be taken as an indication of acceptance criteria. However, acceptance conditions may vary due to changes in licence and operating conditions.

Expanded plastics (eg polystyrene)

The surcharge for larger quantities in mixed loads reflects the real costs of the space taken in landfill.

Garden organics

Untreated timber, pallets, crates, palings, tree branches, grass clippings, prunings and weeds are accepted for mulching and composting if pre-sorted from mixed wastes and excessive amounts of soil. Tree branches / timber must be less than 1 metre long and 150mm diameter. Timber must not be chemically treated, painted or stained. Loads containing materials such as bricks, metal or general rubbish will be charged as mixed waste. Loads containing palm trees or fronds will be charged at the Palm Trees and Fronds rate.

Mattresses

Mattresses are charged at \$20.00 each. An ensemble is charged as one mattress. Limit of one ensemble or two individual mattresses per visit. Larger quantities require a special booking. Call 1300 651 116.

Mixed construction and demolition material

Construction and demolition material includes bricks, concrete, terracotta tiles and pipes, asphalt, sand and soil with minimal quantities of light materials such as timber, plasterboard, plastic, metal and clay. These materials are accepted for disposal at Belrose, Eastern Creek, Jacks Gully and Lucas Heights. Loads must not contain garden organics or asbestos. Call 1300 651 116 for full details.

Paint (household quantities)

Note: Charges apply to container size, not the amount of paint contained. Paint is charged at \$1.00 per 1 litre of container capacity with a minimum charge of \$5.00. No thinners, solvents or paint related products. Water or oil based paint only. Phone 1300 651 116 for more information.

Label all paint containers. Other wastes are not accepted in the paint disposal area.

The Department of Environment and Climate Change NSW provides free drop off centres for old or left over paints and household chemicals. For further information contact the Environment Line on 131 555 or www.cleanout.com.au

Palm trees and fronds

Includes all palm trunks or fronds. Minimum charge \$30.00. Palm trees and fronds are not accepted at Artarmon and Auburn.

Security Wastes (eg expired food stock) and Special Wastes (eg asbestos sheeting, synthetic mineral fibres and dusty waste).

Also includes bulky loads such as large whole tyres (truck, earthmoving). These wastes must be booked at least one business day before disposal. Other acceptance criteria may apply. For bookings or further information please phone our Customer Service Centre on 9934 7115 or 9934 7000.

Note, one booking number per load.

Separated bricks, concrete (unreinforced only*), roof tiles and terracotta pipes

Sorted loads accepted for recycling at Belrose, Eastern Creek, Jacks Gully and Lucas Heights. Maximum size 700mm in any one direction. One tonne load limit at Eastern Creek. *Only Jacks Gully will accept reinforced concrete.

Tree trunks and roots

Stumps and tree branches over 150mm diameter and up to 3 metres long are accepted for disposal at Belrose, Chullora, Eastern Creek, Jacks Gully and Lucas Heights. Minimum charge \$30.00.

Untreated timber (timber must be less than 1m long and 150mm diameter)

Comprises crates, pallets, hardwood fences and untreated timber only. Must not contain CCA treated or lead painted timber, particle board or MDF. No metal, plastic, concrete or brick contamination. Minimum charge \$25.00.

VENM (Virgin excavated natural material)/clean fill

This material now attracts the waste levy of \$38.60 per tonne. Must be totally free of any contaminants, including topsoil, tree roots and branches, broken concrete, asphalt, bricks, tiles or timber off-cuts. Information on source, and screening for contamination may be requested. Call 1300 651 116 for full details.

Wet material (eg mixed waste containing food)

Accepted at all centres.

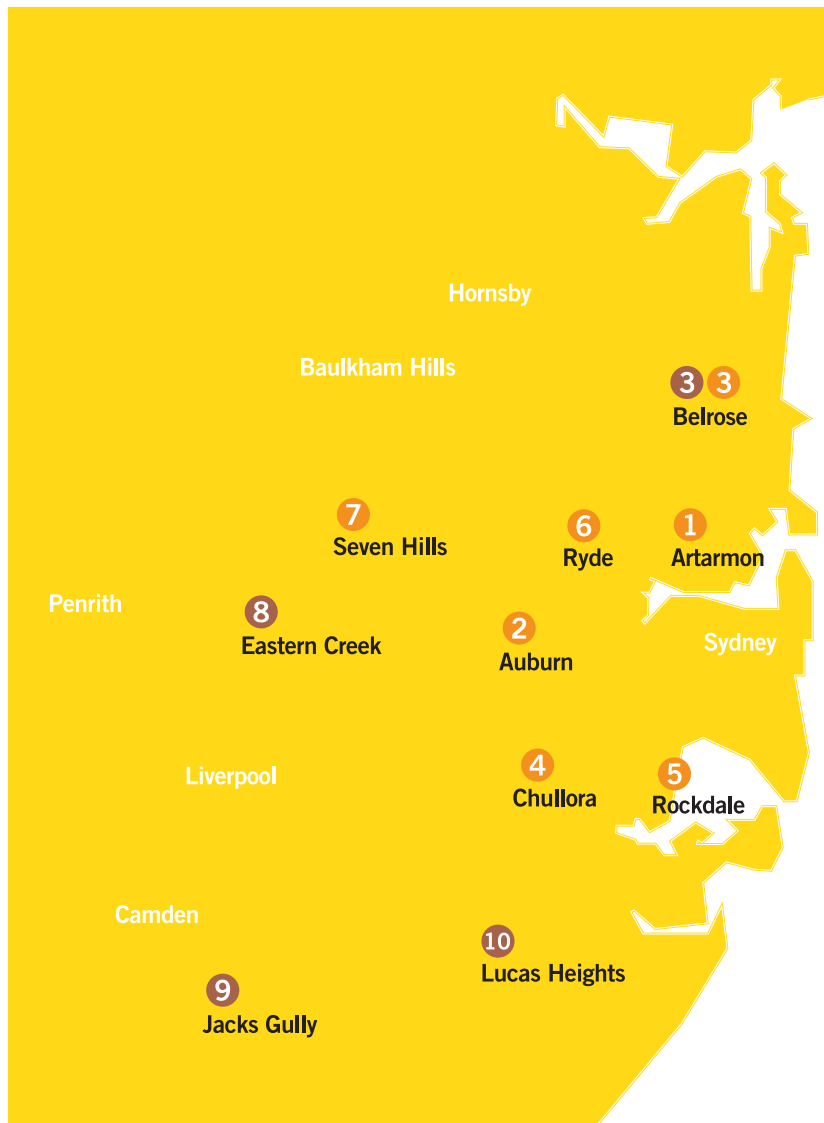
